Open Access Goals of the Dutch Government

- Research funded by public money
 - In 2018: 60% Open Access
 - In 2020: 100% Open Access

Open Access Situation at iCIS

- Sample: Last 200 publications of each group in RIS:
 - DaS: 52 % open access
 - SwS: 48 % open access
 - DiS: 44 % open access
 - (iCIS: only 22 publications in total...)

Open Access Goals of Radboud University

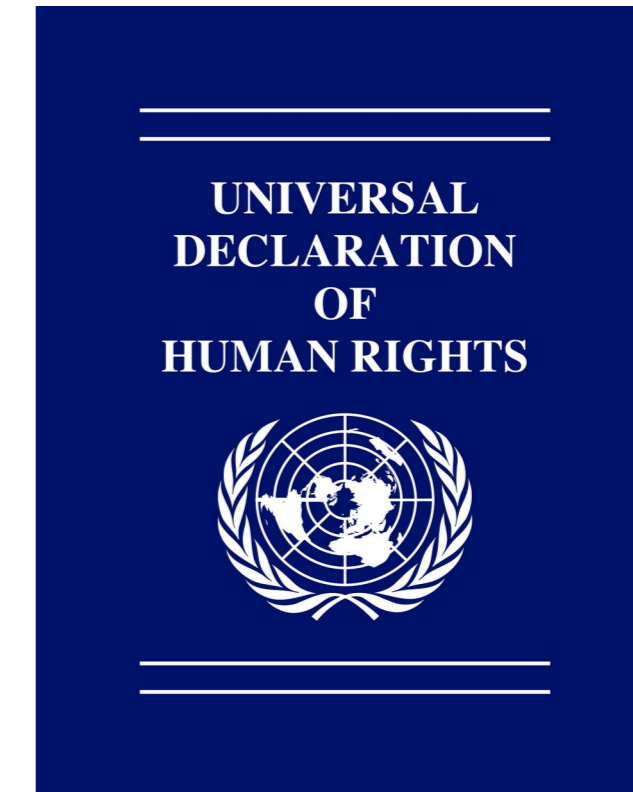

Why? 1. Inclusiveness

- Human Rights (Article 27 of UN Human Rights declaration)
- North-South divide (less than 2% of papers from global south)
- Citizen science
- Startups / Innovation



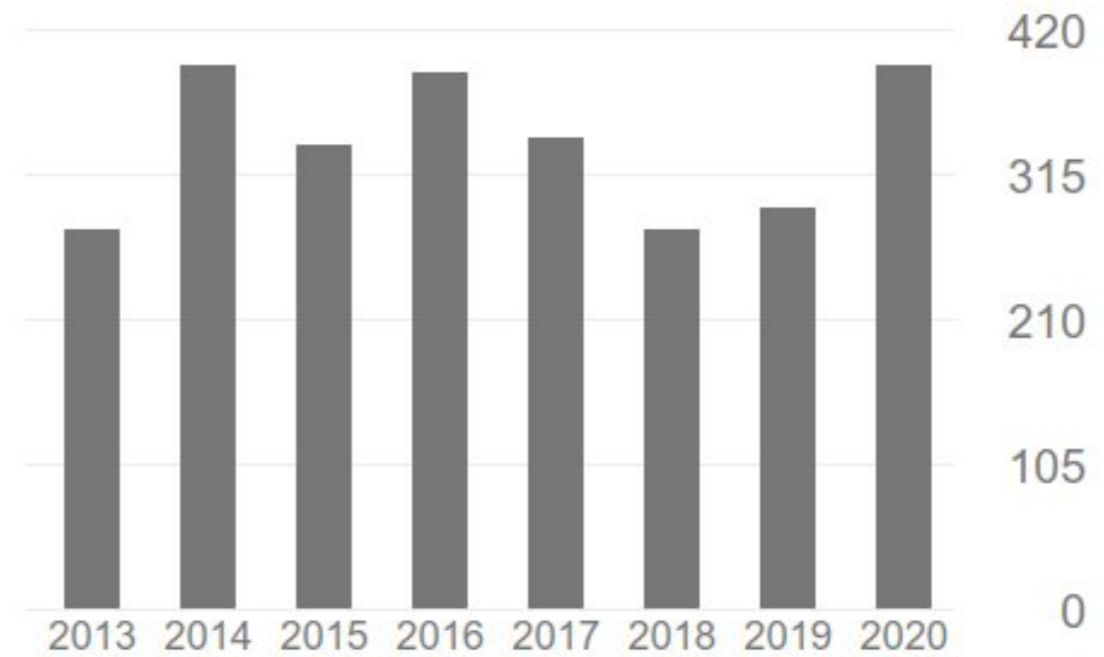

- More citations
- More downloads
- More press coverage

What? The colors of Open Access

- **Green** open access
- **Diamond** open access
- **Gold** open access
- Institutional repository (or author home page)
- At publisher paid by donations (editors, reviewers, staff: volunteers)
- At publisher paid by authors (risk: “double dipping”)

- **Black** open access



Dutch Copyright Law

- Artikel 25fa Auteurswet, per juli 2015

“De maker van een kort werk van wetenschap waarvoor het onderzoek geheel of gedeeltelijk met Nederlandse publieke middelen is bekostigd, heeft het recht om dat werk na verloop van een redelijke termijn na de eerste openbaarmaking ervan, om niet beschikbaar te stellen voor het publiek, mits de bron van de eerste openbaarmaking daarbij op duidelijke wijze wordt vermeld”.

New Strategy of iCIS

- **Green:** **Default:** All iCIS publications Open Access in the Radboud Repository
(after a reasonable time)
- **Diamond:** **Preferred**
- **Gold:** **Discouraged** (Limited reimbursements for article processing charges)
